**1. A brief discussion on functioning of Community College:**

It was reported to the members by dean of vocational programmes Mrs.G.Kalavathi that there is very good response from public for community college and the admissions are very encouraging.

**2. UGC has sanctioned Community College for another 2 years:**

Dr.S.Nirmala principal PSGR Krishnammal College for women informed the board members that UGC has sanctioned the community College courses for another 2 years i.e., 2016-2017 and 2017 and 2018.

#### 4. Admission details:

#### 5. Fees structure:

The secretary Dr.N.Yesodha Devi informed the board members that as per UGC regulations registration fee of Rs.1800 is only collected from students for one year to complete levels namely Level 4 and Level 5.

- (i) Certificate level – Level 4 – 6 months
- (ii) Diploma Level – Level 5 – 12 months

The total training cost, course material, exam fees for different levels and sector skill assessment fees were met out of the grant to be released by UGC. At present all the expenditure relating to functioning of community college is met by the management.

#### 6. Results of the Community College:

The principal Dr.S.Nirmala presented before the board a brief report about the results of the community college for the year 2015-16.

##### 1) Garment Designing Course:

- (i) Certificate Level 100%
- (ii) Diploma Level 100%

##### 2) Multimedia & Animation Course:

- (i) Certificate Level 100%
- (ii) Diploma Level 100%

The members appreciated the college for the effective functioning of the community college and for the good results produced.

## **7. Internship and hands on training to students:**

Mrs.G.Kalavathi – Dean vocational programme presented before the board the list of industries where the community college students had undergone internship training.

The details of placement for advanced diploma students were also presented before the Board of Management.

## **8. Assessment by Sector Skill Council:**

The community college students were assessed by Apparel Made-ups & Home furnishing Sector Skill Council for certificate Level (Level 4) and all the students completed Level 4 successfully in Feb 2015.

During the current year students admitted in 2015-16 will undergo sector skill assessment in September 2016.

Assessment fees of Rs.800 per student has already been paid to sector skill council .Community College students will appear for exam in Sep 2016.

## **9. Role of partner industries:**

Mrs.G.Kalavathi – Dean vocational programmes explained before the board that the industries with whom we had entered into MOU has helped a lot for internship of students and the students are trained well in Garment Industries and in Multimedia & Animation companies.

## **10. Statement of accounts for 2015-16:**

The statement of accounts for community college for 2015-16 was placed before the BOM members. The members discussed in detail & recorded the same.

## **11. Suggestions given by members:**

A college campus company can be established and students of community college can become partners and the students company can take up fashion designing for the customers inside the campus.

Reputed companies in garment sector and multimedia & Animation sector should be invited for placements.
