



### **Minutes of the 30<sup>th</sup> Meeting of the Academic Council**

- **The 30<sup>th</sup> Meeting of the Academic Council was held on 01.08.2024 at 10.00 am through Hybrid Mode in the Conference Hall in KCW campus.**
- **Dr. Shamitha Begum, Dean – Academic Affairs introduced Dr. P. B. Harathi as the Principal and also the new Chairman of the Academic Council from 2024-2025 and onwards.**
- **Principal, Dr. P. B. Harathi, welcomed the Council members, Deans and Directors of various capacities and Heads of the Departments and the Academic Council Team members.**
- **Principal sought approval and confirmation of the minutes of the last meeting of the Academic council which was held on 13<sup>th</sup> February 2024. It was accepted and approved.**

#### **ITEM I**

**To approve and consider the starting of new programmes M.Sc. Environmental Science, M.A. Applied Economics, B.Sc. Data Science and B.Com. (FinTech) from the academic year 2024-25 and onwards.**

The resolution was passed. It was seconded and approved by Dr. R. Rajendran, Associate Professor, Department of Microbiology, PSG College of Arts & Science, Coimbatore. He also insisted on the employability of the new programmes.

#### **ITEM II**

**To approve the changes in the scheme of examinations, Question paper pattern and evaluation for both UG and PG programmes (excl. MBA) from the academic year 2024-25 and onwards.**

Dr. Shamitha Begum, Dean Academics mentioned the following changes and sought approval

- a) Introduction of 'GEN AI' in semester III of all UG programmes of 2023-2024 batch in the Skill Enhancement Course category
- b) All the existing Skill Based Courses offered by various departments and the newly introduced Skill Based courses like Drone Technology, Gen AI courses and Coursera courses (45 hrs) are pooled together in the Skill Hub.
- c) Changes in the Attendance Mark Slab

The change in Attendance mark slab from the academic year 2024-2025 for all batches.

75 to 80% : 1 Mark, 81 to 90% : 2 Marks, 91 to 100% : 3 Marks

- d) Design Thinking Course is shifted from semester IV to semester III. Universal Human Values and Human Rights will be a self-study course with grade for 2023 - 2024 batch.
- e) To approve and ratify the introduction of Lions Club of Coimbatore – PSGR Krishnammal College for Women in Part V – Extension Activity from the academic year 2024-2025 onwards.
- f) As TNPSC is insisting on getting an equivalence certificate from TANSCH for programmes with new nomenclature to facilitate the students to get into Public Services in Tamil Nadu, approval of the Council is requested to apply for the same.

The resolution was passed. It was seconded and approved by Dr. Rajendran.

### **ITEM III**

**To approve the changes in the syllabi, curriculum, scheme of examinations and question paper pattern of part I language – Tamil of undergraduate and B.Voc. programmes for semesters III & IV from the academic year 2024-25 and onwards.**

The resolution was passed. It was seconded and approved by Dr. N. Ponpandian, Professor and Head, Department of Nanoscience and Technology, Bharathiar University, Coimbatore. Dr. Rajendran questioned the necessity of offering language courses to B.Voc.

students and it was justified that learning of language is necessary to make the students eligible for Tamil Nadu Public Service Commission exams and other competitive exams.

#### **ITEM IV**

**To approve the changes in the syllabi, curriculum, scheme of examinations and question paper pattern of part I language – Hindi of undergraduate and B.Voc. programmes for semesters III & IV from the academic year 2024-25 and onwards.**

The resolution was passed. It was seconded and approved by Dr. Ponpandian and Dr. Rajendran.

#### **ITEM V**

**To approve the changes in the syllabi, curriculum, scheme of examinations and question paper pattern of part I language – French of undergraduate and B.Voc. programmes for semesters III & IV from the academic year 2024-25 and onwards.**

The resolution was passed. It was seconded and approved by Dr. Rajendran. He confirmed the justification of revision of syllabus and it was justified by Dr. Jeevitha, Head, Department of French that the syllabus revision for II UG helps them to prepare for entrance exams for MA French.

#### **ITEM VI**

**To approve the changes in the curriculum and syllabi of, part III courses of B.A. English Literature in semesters I, III and V & changes in the III semester courses of M.A. English Literature from the academic year 2024-25 and onwards.**

The resolution was passed. It was seconded and approved by Dr. Rajendran. He also appreciated the regional inclusion of content in the syllabi.

#### **ITEM VII**

**To approve the changes in the curriculum and syllabi of part III courses of B.A. Economics, for semesters I, III & V from the academic year 2024-25 and onwards.**

#### **ITEM VIII**

**To approve the changes in the curriculum and syllabi of part III courses of B.A. History, for semesters I, III & V and changes in the III semester course of M.A. History from 2024-25 batch and onwards.**

The resolution was passed. It was seconded and approved by Dr. Rajendran. He also confirmed the success stories of students clearing Civil Service Examinations. It was justified that one student from Economics Discipline has cleared the recent Group I Exam and also from Chemistry, Botany and Commerce discipline.

#### **ITEM IX**

**To approve the changes in the curriculum and syllabi of part III Allied Mathematics courses in semester I from the academic year 2024-25 and onwards.**

The resolution was passed. It was seconded and approved by Dr. Rajendran. He enquired about the admission status for Mathematics courses and also suggested to enrich the syllabus with Computer applications and to have MoU with companies / industries of software connect. It was justified that the syllabus was already enriched with content including AI and its application in all courses of Mathematics wherever applicable.

#### **ITEM X**

**To approve the changes in the curriculum and syllabi of part III - III semester course of B.Sc. Physics and changes in the III semester course of M.Sc. Physics from 2024-25 batch and onwards.**

The resolution was passed. It was seconded and approved by Dr. Rajendran. He also insisted on including courses on Bio - Material Science.

#### **ITEM XI**

**To approve the changes in the syllabi of part III courses of B.Sc Botany, for semesters I, III & V and M.Sc Botany in semesters I & III from the academic year 2024-25 and onwards.**

The resolution was passed. It was seconded and approved by Dr. Rajendran and Dr. R. Sathishkumar, Professor and head, Dept of Bio – Technology, Bharathiar University, Coimbatore.

#### **ITEM XII**

**To approve the changes in the curriculum and syllabi of, part III courses of B.Sc. Zoology, in semesters III &V and for M.Sc. Zoology in semesters I & III from the academic year 2024-25 and onwards.**

The resolution was passed. It was seconded and approved by Dr. Rajendran. He insisted on including at least a unit on Genetic diseases.

#### **ITEM XIII**

The resolution was passed. It was seconded and approved by Dr. Rajendran. He appreciated the introduction of AI in the Marketing course. He further applauded 33 students clearing CA – Intermediate Exam, 70 students clearing CA Final exam from 2009 to 2024.

#### **ITEM XIV**

**To approve the changes in the curriculum and syllabi of part III courses of B.Com. CA, B.Com. (e-commerce), B.Com (Accounting & Finance), B.Com (Financial services), B.Com. (Professional accounting) for semesters I, III & V and I & III semesters courses of B.Com. (Actuarial management), B.Com. (Business analytics) and changes in semesters I & III courses of M. Com. from the academic year 2024-25 and onwards.**

The resolution was passed. It was seconded and approved by Dr. Rajendran. He suggested changing the nomenclature of the board as Applied Commerce Course instead of Commerce SF.

The resolution was passed. It was seconded and approved by Dr. Rajendran. He appreciated inclusion of recent topics like AR/VR/AI/ Reverse logistics in all the courses wherever applicable.

She appreciated the introduction of Data Visualising and Gen AI. Dr. Rajendran and Dr. Punithavalli suggested using AI tools in the areas of Students' Group projects and research.

The resolution was passed. It was seconded and approved by Dr. Punithavalli. Dr. Rajendran enquired about the inclusion of ChatGPT in the curriculum and it was justified that it is included as a part of AI tools in curriculum.

It was justified that change in nomenclature may fail to pass course approval and hence students may be suggested to do projects on these specialization areas which help them for employability.
